## RULES & REGULATIONS:

SATYAM : (Code:100)

Home for the Aged.

A set of guidelines as stated below are evolved for admission of the Aged/Aged-poor/Aged-Destitute/Orphan-Boys to ensure disciplined and peaceful environment in the ACT.

- A. Economic status of the person, his role in the family, particulars of his social service and the reason behind his admission in the ACT, should be informed and justified.
- B. Person's back-ground (Political,Social,Criminal and others) should be informed and justified
- C. Person's state of health: Whether he has any specific problems/Is he or she mentally healthy/Can he or she adjust to the ACT environment and circumstances / State of eye sight, etc., should be informed. The ACT will confirm the admission only after assessing.
- D. Person should respect the rules and regulations and should take part in prayer, yoga, Satsang, voluntary service and general activities etc. of ACT.
- E. All inmates are treated equal in terms of food.
- F. Talking aloud, shouting, fighting is not allowed in the ACT. All inmates should see, that they abide by the rules and regulations so that the internal peace of the ACT is not disturbed.
- G. ACT inmates are prohibited to discuss the topics related to personal life and other irrelevant matters beyond the permitted scope.
- H. ACT management will have a right to make rules to allot/change rooms depending on the person's habits and situations.
- I. ACT holds all rights to send the inmate if the person is found to have not adjusted to the ACT rules and lifestyle.
- J. Smoking, consuming alcohols, Gutka, playing cards, or any other similar Activities in nature are strictly prohibited within the premises of the ACT. All inmates should abide by this rule.
- K. In case of health problem to any inmate, ACT can provide available medical assistance and inform the caretaker/relative, who admitted the Aged/Aged-poor/Aged-Destitute/Orphan-boys into ACT as the case may be, in any event of inmate's death, the ACT will inform the same to the concerned address. In case there is no response from the concerned, the ACT will inform police station and will hold all rights to perform final rites of the departed.
- L. Trustees and organizing members & supervisor can check the ACT rooms and verify their activities,etc.,at any time. Trust details including members' photos will be kept in website.
- M. ACT Organizing Committee holds all rights to include any kind of rules and regulations on consulting the Trust.
- N. Details of two caretakers/relatives/identifiers as the case may be, submitted to satisfy the ACT, to enable the ACT to contact in case of emergency and also have coordination in solving the problem, if any.
